2. This application under Section 11 of the Contempt of Court Act has been filed for the alleged non-implementation of the order dated 31.3.1999 (Annexure-3), passed learned Single Judge of this Court in a contempt application bearing M.J.C. No. 2231 of 1998 (Hridyal Kumar and others Vs. The State of Bihar & Ors.), which, in ts turn, was filed for the alleged non-implementation of the judgment dated 3.2.1998, passed by a learned Single Judge of this Court in C.W.J.c. No. 1376 of 1997 (Hridyal Kumar and others Vs. The State of Binar & Ors.). The petitioner alleges that this Court on both the occasions had directed that to a large number of appointments including those of Labour Enforcement Officer, Department of Labour, Government of Bihar, shall be made in accordance with the directions made therein, and the established procedure.

first ascertain the vacancies upto 31st December, 1993 which are still lying vacant and make such requisition, if not yet made, to the B.P.S.C. within three months from the date of receipt/production of a cdpy of this judgment.

It is manifest on a plain reading of the direction in the judgment extracted hereinabove that the post of Labour Enforcement Officer in the Department of Labour was not in question in the writ petition and obviously, therefore, could not have been the subject matter of the said M.J.Q. No. 2231 of 1998. In spite of repeated queries, learned counsel for the petitioner has not been able to satisfy the Court that any direction was issued in the writ petition or the contempt application with respect to the post of Labour Enforcement Officer, and the present petitioner was a petitioner therein.
