level 6 & Level 7 resp. as per the guidelines issued for board level appointment in CPSEs issued by DoPT, MoPPG&P, GoI in 2017 (Annx.-4 attached by the candidate in the e-mail sent on 31 Aug. 2024) and equivalent to level 7 and level 8 resp. as per NHAI policy Circular No. 1.3.1.25/2022 dated 17 June 2022 (Annx. 5 attached by the candidate in the e-mail sent on 31 Aug. 2024).

According to the Revised pay scale by ONGC uploaded on 11.01.2018 (Annex-3A attached by the candidate in the e-mail sent on 31 Aug. 2024), the revised pay scale for E1 & E2 are 60000-180000 & 70000-200000 respectively while the then existing pay scale was 24900-50500 and 29100-54500 respectively, which are wrongly claimed by the candidate as level 10 & 11 respectively.

Thus the candidate does not possess the minimum required work experience as per the advt. i.e.,
