The entire recruitment process includes three phases — Preliminary Exam, Mains Exam and Personal Interview with eligibility tests. There is an existing online Application management system through which candidates can apply for the exam, download Admit Card etc. This online Application management system also provides facility for Pre and Post examination related activities for different types of exams.

BPSC intends to select competent agency/ system integrator to design, development, implement and management of a new online application portal covering the complete lifecycle management of the application for various exams along with Website in order to provide additional functionalities to the candidates and other stakeholders.
