Reason As per Set-A

Q.No.- 05 - The provisional answer is option 'C', But the correct answer is option 'D'.

Reason :- Option 'D' i.e., Sister-in-Law is correct.

Q.No.- 08 - Deleted.

Reason: Without actual length of path or position of one point with respect to the other, the relative position will vary. In the question, the actual positional distance is missing. Hence more than one answer is possible.

Q.No.- 10 - No Change.

Reason: Option 'A' i.e. 17 is the correct answer.

Q.No.- 31 - No Change.

Reason :- The Statement A and B both are correct. Hence option 'D' is the correct answer.

Q.No.- 33 - No Change.

Reason :- A person disqualified under any law in force cannot occupy an elected post.

Q.No.- 34 - Deleted.

Reason :- The question has several mistakes. The Sarkaria Commission was not a Committee. It was established in June 1983 and not in March 1983. It was not a one man commission. There were two more members. Option A and C both are same, therefore two options are correct. Hence the question is deleted.

Q.No.- 35 - No Change.

Reason: The National Development Council does not exist any more.

Q.No.- 37 - No Change.

Reason :- The President of India has exercised his power of veto only for 'Indian Post Office (Amendment Bill)'. The Bill mentioned in option 'D' (PEPSU Appropriation Bill) was never sent to the president by the Parliament and was stopped for legal reasons.

Q.No.- 44 - Deleted.

Reason :- The Bihar Provincial Kisan Sabha was established in 1929. None of the options are correct.

Q.No.- 61 - No Change.

Reason :- Indian Monsoon is greatly affected by the Himalayan Mountain Range.

The height of Western Ghats has rain shadow effect only in Peninsular India.

Q.No.- 62 - Deleted.

Reason :- Option 'C' (Moreh Pass) and 'D' (Tuirial Pass) both are not located between Arunachal Pradesh and Myanmar. Moreh is not a Pass but a gateway in Manipur. Tuirial is not a Pass but a river in Mizoram.

Q.No.- 68 - No Change.

Reason :- The Ground water has a small role in North India and no role in Deccan Plateau.

Q.No.- 84 - Deleted.

Reason :- All the four options are correct examples of metal clusters. Hence the question is deleted.
